

LETTER FROM THE PRESIDENT

Local solutions to face social inequalities

The data are not always real, but those of poverty unfortunately are. Again, the figures show how chronic poverty is becoming, which forces us to express actions and to give answers, especially

from proximity, because who better than we social entities, who know the support that the people need and the resources of the community and the local authorities, the administrations closest to the citizens, to build local and joint solutions to social inequalities? And this is where we have precisely placed the focus this year through the 6th Third Sector Congress, where we have discussed and reflected on how to strengthen synergies between local administrations and the social sector to develop brave and determined social policies, and through the Third Sector Barometer, a tool that has allowed us to deepen the relationship established between the local administrations and the social entities.

In the fight against poverty, we also wanted to make two of its faces visible: energy poverty and the feminisation of poverty, by promoting debates and 'Social Catalonia' dossiers on the price of energy as a key factor that hinders guaranteeing the right to energy, and about single parenthood and poverty, in addition to co-organising the 2nd Catalan Congress of Energy Poverty, which has analysed the causes that aggravate this social problem.

We have been able to do all this, despite the moments of institutional blockade. The Third Sector has once again demonstrated its resilience and the social entities, faithful and committed to the public service mission, have remained alongside the people. A good reason for collective pride.





■ We follow up on the **implementation of the Citizens** Guaranteed Income and we participate in drawing up the Urban Agenda of Catalonia, the Zero Poverty Platform and the activities of EAPN Spain.

- We work to redefine the distribution model of 0.7% of Income Tax and to improve the forms of justification of 2018.
- We joint organise the **2nd Catalan Energy Poverty Congress**, we meet the main supply companies to defend law 24/2015, we work on the application of the new decree of the social good and we take part in the ASSIST2gether.
- We create a **work group with the SOC** to improve the legal security of the subsidies related to the Social and European Funds, the Table and The Confederation and we collaborate with the Pedrosa Business Association.

■ We complete the diagnosis of the situation and perspectives of the community care model in the Third Sector in Catalonia, and we weave alliances with other social and political agents to change the care model and approach person-focused community care.

■ We attend the **Territorial and Coordination** Consultative Boards of Public Health of Lleida, Alt Pirineu and Aran and Girona regions and we take part in the 'Social and Health Care Integration report' of the CTESC and in the Barcelona City Hall work group on dealing with integrated social and healthcare.

1st Mission of the Table in Europe

A delegation of Federated entities travels to Brussels to visit the European Parliament and hold meetings with European platforms and associative networks (Social Services Europe, ENIL, EAPN Europe and CIRÉ) in order to:

- Better know the functioning of the European legislature.
- Identify possible community financing lines and funds.
- Better define the associative networks and European platforms concerning the Third Sector.
- Promote intercommunication and political influence in Europe.
